Pfizer Hospital is committed to providing timely supply information so that you can plan for patient care. As such, we want to update you on the latest availability of Pfizer Hospital Surgical Brands. We remain in good supply on all presentations except Thrombin-JMI™ (thrombin, topical [bovine] USP) 5000 IU Vial with Diluent, 60793-0215-05. We are anticipating intermittent receipts of inventory over the next few weeks, which can cause potential locational backorders through the end of the year.

The table directly below denotes the supply status of each of Pfizer Hospital's Surgical Brands presentations. While most of the presentations remain available in full, supply of Thrombin-JMI™ (thrombin, topical [bovine] USP) 5000 IU Vial with Diluent, in particular, will be constrained. To help ensure equitable distribution of this specific presentation, we will be allocating to Wholesaler and Distributors at 80% of historical demand throughout the end of the year.
