Availability Update for Bicillin® L-A (penicillin G benzathine injectable suspension) and Bicillin® C-R (penicillin G benzathine and penicillin G procaine injectable suspension) Prefilled Syringes

Dear Customer,

Pfizer Hospital is committed to providing timely supply information so that you can plan for patient care. The purpose of this letter is to make you aware of a limited supply and impending stock out situation for select Bicillin® L-A (penicillin G benzathine injectable suspension) and Bicillin® C-R (penicillin G benzathine and penicillin G procaine injectable suspension) Prefilled Syringes.

The supply interruption is the result of a complex combination of factors including significant increases in demand, due to an increase in syphilis infection rates as well as competitive shortages. In order to meet this increased demand, Pfizer has prioritized manufacturing capacity to Bicillin® L-A (penicillin G benzathine injectable suspension) 1.2 million Units/2 mL and 2.4 million Units/4 mL (600,000 units/mL) Prefilled Syringes.

At this time all Bicillin® C-R (penicillin G benzathine and penicillin G procaine injectable suspension) are estimated to deplete in Q3 2023 and Bicillin® L-A (penicillin G benzathine injectable suspension) Pediatric (600,000 units/mL) Prefilled Syringes are estimated to deplete by end of Q2 2023. These presentations will not be available until further notice.
