### ABBOJECT® Emergency Syringe Platform Update

Dear Valued Customer,

Pfizer Hospital is committed to providing supply information so that you can plan for patient care. As such, the purpose of this letter is to make you aware that, after a thorough assessment, **Pfizer has made the decision to no longer supply the ABBOJECT® Emergency Syringe Platform.** Importantly, this decision is not due to any safety or efficacy issues related to our ABBOJECT® products, and the U.S. Food and Drug Administration (FDA) has been notified.

We understand the critical importance of emergency ready-to-use presentations to hospitals and patients. Unfortunately, the ABBOJECT® syringe platform has faced supply disruptions in recent years, and there is no additional inventory available. As market demand is currently being supported by alternatives, including Pfizer's ANSYR® Syringe line, Pfizer's vial presentations, and/or alternatives from other manufacturers, we do not anticipate that this decision will result in access challenges. This decision will allow Pfizer to focus on other areas of our sterile injectables portfolio and manufacturing network in support of our ongoing commitment to supplying essential sterile injectable medicines to U.S. hospitals and patients.
