**Availability Update for Bicillin® L-A (penicillin G benzathine injectable suspension) Prefilled Syringes**

Dear Customer,

Pfizer Hospital is committed to providing the most up-to-date supply information so that you can plan for patient care. As such, we would like to provide an availability update following the July 10, 2025 communication regarding **Bicillin® L-A (penicillin G benzathine injectable suspension)**

**2.4 million Units/4 mL (600,000 units/mL) Prefilled Syringe** and **Bicillin® L-A (penicillin G benzathine injectable suspension) 1.2 million Units/2 mL (600,000 units/mL) Prefilled Syringe.**

This week we will begin shipments to wholesalers at 35% and 40% of historical purchases, respectively:

- **Bicillin® L-A (penicillin G benzathine injectable suspension) 1.2 million Units/2 mL (600,000 units/mL) Prefilled Syringe** at 35% historical purchases
- **Bicillin® L-A (penicillin G benzathine injectable suspension) 2.4 million Units/4 mL (600,000 units/mL) Prefilled Syringe** at 40% historical purchases

Additionally, Bicillin® L-A (penicillin G benzathine injectable suspension) Pediatric 600,000 Units/mL Prefilled Syringe is on track to return to market with next anticipated delivery in late October 2025.

Please begin to source products from your wholesalers. In addition, for situations in which customers cannot access products through their wholesaler, we will continue to operate Pfizer's **Medical Request Process**, initiated on July 10, 2025, for requests of **Bicillin® L-A (penicillin G benzathine injectable suspension) 1.2 million Units/2 mL (600,000 units/mL)** and **Bicillin® L-A (penicillin G benzathine injectable suspension) 2.4 million Units/4 mL (600,000 units/mL) Prefilled Syringe**. Products available through the Medical Request Process will continue to be prioritized for patients with the highest medical necessity, which, based on prior Centers for Disease Control (CDC) guidance, is patients with confirmed congenital syphilis and risk of congenital syphilis.

We will continue to provide updates as they become available.

### Medical Request Process Instructions for Customers:

- Bicillin® L-A (penicillin G benzathine injectable suspension) 1.2 million Units/2 mL (600,000 units/mL) Prefilled Syringes and Bicillin® L-A (penicillin G benzathine injectable suspension) 2.4 million Units/4 mL (600,000 units/mL) Prefilled Syringes will be available for direct or drop shipment through Pfizer's Medical Request Process. However, customers should first check with local wholesalers and within their hospital system for any potential remaining inventory before making a medical request.
  - Customers who do not have an active direct Pfizer account may be able to utilize the drop shipment option once their Medical Request Form has been approved and their wholesaler approves. To place an order, please contact your authorized wholesaler or distributor after the Medical Request form has been approved. The wholesaler or distributor will submit the order to Pfizer Hospital, and the products will be shipped directly to the customer.
  - Customers with an active direct Pfizer Account should place orders through [Pfizer Prime](#) following the approval of their Medical Request Form.
- Pfizer will distribute available inventory in accordance with its medical request process, which requires that customers complete a [medical request form](#) to request product on a per patient basis.
- The [medical request form](#) must be completed by the institution and authorized and emailed by the treating Health Care Provider or Director of Pharmacy on a per patient basis to receive product.
- Completed forms should be emailed to [PISupplyContinuity@pfizer.com](mailto:PISupplyContinuity@pfizer.com).
- Requests will be reviewed and filled in the order they are received and only with the required documentation. Cut off time for overnight requests is 3 p.m. (CT), and no deliveries will occur on Sundays.

Thank you for your patience as we continue to work through this limited supply situation.
