## Product NDC Changes

Dear Valued Customer,

Pfizer is pleased to share that **Dopamine Hydrochloride in 5% Dextrose Injection, USP 400 mg/250 mL (1,600 mcg/mL) Flexible Container** and **Dopamine Hydrochloride in 5% Dextrose Injection, USP 800 mg/250 mL (3,200 mcg/mL) Flexible Container** with updated NDCs are now available at wholesalers and distributors, as well as via direct order from Pfizer (please note locational inventory may vary).

While there are differences in NDCs, as detailed in the Product Information table below, please note there are no changes to unit of sale sizes or indications. We are requesting that customers begin to order the new NDCs, 00409-0042-12 and 00409-1858-12, for any future orders as the current NDCs are already depleted.

## 340B INVENTORY REPLENISHMENT

Pfizer recognizes that a product transitioning to a new NDC number can impact product inventory accumulations for 340B covered entities. The Product Table below outlines both the existing and new NDCs. Because the new NDCs are for the same product (drug, dosage form, and package size) and have the same 340B prices as the corresponding existing NDCs, eligible 340B covered entities may use a 340B compliant inventory replenishment model to transfer accumulations of the old NDCs toward replenishment of equal quantities of the corresponding new NDCs.




