340B INVENTORY REPLENISHMENT

Pfizer recognizes that a product transitioning to a new NDC number can impact product inventory accumulations for 340B covered entities. The Product Table below outlines both the existing and new NDCs. Because the new NDCs are for the same product (drug, dosage form, and package size), and have the same 340B price as the corresponding existing NDCs, eligible 340B covered entities may use a 340B compliant inventory replenishment model to transfer accumulations of the old NDCs towards replenishment of equal quantities of the corresponding new NDCs.




